What to Expect: Governing by Brian Vinson

Like county, state and federal government, the Town of Poetry is a representative government. The citizens elect a council that represents them to create the laws and ordinances for the town and a mayor to enforce those laws and ordinances.

Elections are held to ensure that the people of the town retain faith in their elected officials. This frees the citizens from the burden of government as well as the research, deliberations, and administration involved in government while ensuring they have acceptable representation.

Your elected officials will be responsible to you the voter for their decisions. They will make decisions constantly throughout their term, so the voice of the citizen will be heard constantly through citizen involvement.

Referendums have been referenced by candidates and non-candidates lately. Texas law allows the municipality to call a referendum for a few, specific circumstances. The primary use of a referendum, however, is for the citizens to force the municipality to address something it otherwise wouldn't or hasn't. A referendum is a public vote and it is handled like an election. By state law it must be handled (with few exceptions) on a uniform election date (twice a year) and must be paid for by the person or group

calling for it. Therefore, if the town called a referendum the tax payers would have to pay for it.

What to Expect: Open Meetings

Every elected official will to be certified in the Open Meeting Act within 90 days of taking office. I went ahead and got my certification so I could create this post and share the information with you, the voters.

Texas has an *Open Meetings Act* that is an attempt to ensure the decision making of government is open and transparent to the people. Governing officials violating the Open Meeting Act can be held criminally or civilly (fines and/or incarceration) liable for such violations. Texas takes it very seriously.

You should be able to understand what decisions are being made on ordinances and laws that impact you. Discussions must meet certain requirements.

Meetings must be announced - usually at least three days ahead of time - and must include when and where the meeting will be held as well as an appropriate agenda of what will be discussed.

There are only a few - and very specific - exceptions to what can be discussed in closed session, but no final vote can be held in closed session. **Final votes must be made in open session.** Gone are the days of 'smoky back room deals', at least if the law is followed properly.

New rules do allow for deliberations and discussions to be held online. However, the site must be controlled by the governing body (the town in our case), must allow for 30 days of online archiving and 6 years of offline archiving and have proper notices. Holding deliberations (which could be a councilperson just sharing random thoughts on a subject) through other online sites or social media could be a violation.

Another new rule establishes that meetings must include time for public feedback. The town can establish a fair time limit for feedback, but anyone who wants to address the town must be allowed to do so.
