## ORDINANCE NO. <u>2021-0</u>9-02

AN ORDINANCE OF THE TOWN OF POETRY, TEXAS ADOPTING A BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2021, AND ENDING SEPTEMBER 30, 2022, IN ACCORDANCE WITH STATE LAW; PROVIDING FOR THE FILING OF THE BUDGET AS REPRESENTED IN EXHIBIT "A"; PROVIDING FOR THE INCORPORATION OF PREMISES; PROVIDING A CUMULATIVE REPEALING CLAUSE; PROVIDING SEVERABILITY; PROVIDING AN ENGROSSMENT AND ENROLLMENT CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Poetry, Texas, ("Town"), is a Type A general-law municipality created in accordance with the provisions of Chapter 6 of the Texas Local Government Code and operating pursuant to the enabling legislation of the State of Texas; and

**WHEREAS**, pursuant to Section 102.006 of the Texas Local Government Code, the Town Council held a public hearing on the proposed budget on July 20<sup>th</sup>, 2021; and

**WHEREAS**, the Town Council now wishes to adopt the proposed budget for fiscal year beginning on October 1, 2021, and ending on September 30, 2022, through a record vote, pursuant to state law.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF POETRY, TEXAS, THAT:

**SECTION 1. INCORPORATION OF PREMISES.** All of the above premises are found to be true and correct and are incorporated into the body of this Ordinance as if copied in their entirety.

**SECTION 2. BUDGET ADOPTED.** The budget of the revenues of the Town of Poetry and the expenses of conducting the affairs thereof for the ensuing Fiscal Year beginning October 1, 2021 and ending September 30, 2022, as modified by the Town Council, be, and the same is, in all things, adopted and approved as the said Town of Poetry Budget for the Fiscal Year beginning the first day of October, 2021, and ending the thirtieth day of September, 2022.

**SECTION 3. FILING OF BUDGET.** A true and correct copy of this Ordinance along with the approved budget as represented in attachment **Exhibit "A"**, and any amendments thereto, shall be filed with the Town Secretary. In addition, the Mayor or designee is hereby directed to file or cause to be filed a true and correct copy of this Ordinance along with the approved budget as represented in Exhibit A attached hereto, and any amendments thereto, in the office of the County Clerks of Hunt and Kaufman Counties, Texas, as required by law.

SECTION 4. CUMULATIVE REPEALING CLAUSE. This Ordinance shall be cumulative of all provisions of ordinances of the Town of Poetry, Texas, as amended, except where the provisions of this Ordinance are in direct conflict with the provisions of such ordinances, in which event the conflicting provisions of such ordinances are hereby repealed.

SECTION 5. SEVERABILITY CLAUSE. It is hereby declared to be the intention of the Town Council that the phrases, clauses, sentences, paragraphs and sections of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance, since the same would have been enacted by the Town Council without the incorporation in this Ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

SECTION 6. ENROLLMENT/ENGROSSMENT CLAUSE. The Mayor or designee is hereby directed to engross and enroll this Ordinance by copying the exact Caption and Effective Date clause in the minutes of the Town Council and by filing this ordinance in the ordinance records of the Town.

SECTION 7. EFFECTIVE DATE. This Ordinance shall be effective upon its adoption on second and final reading as the law requires.
