

Financial:

The town's revenues from Sales & Use Tax for June were \$8529.55. **Mayor Senkevech** reported on Third Quarter Budget vs. Actual. The Town is at 66.4% of total. This means the town is within (below) budget for the first 9 months of the fiscal year. Councilmember Anderson and Mayor Senkevech reported on the Town Hall construction progress and budget. The mayor stated the move-in can happen within the \$15,000 budget given. Move-in is expected to happen prior to the September 21st meeting.

- <u>Approved</u> Minutes from the June 5th and June 20th meetings.
- <u>Voted</u> to pay the town's legal bill of \$245.01 for June.
- <u>Discussed</u> making a monthly report of revenue, expenses, and balances on Sales & Use tax receipts with road fund balance. [One hundred percent of Sales & Use tax revenues must go to the road fund by law].
- Voted in Public Hearing to approve the Volunteer Annexation of the Lori & Andy Bass property.
- <u>Discussed</u> the Zero Zoning Ordinance presented by <u>Councilmember White</u>.
 Council decided to bring it back next meeting with the attorney present.
- <u>Discussed</u> the "1445 agreement" which would allow Kaufman County to approve all building requirements in the ETJ of the Poetry area. The council decided to bring it back with amendments and the attorney present for the next meeting to discuss further.
- <u>Mayor</u> discussed the applicants for city secretary coming in with Indeed.com.
- <u>Voted</u> to allow Deputy City Secretary, Theresa Scholander, to move Town hall office hours to Thursdays 1-5 pm to accommodate her therapy classes. She is also allowed to flex to add in hours up to 10 extra per week while the city secretary's job is vacant.

The meeting adjourned at 8:21 pm.
