RESOLUTION NO. 2022-09-01R

A RESOLUTION OF THE TOWN OF POETRY, TEXAS AUTHORIZING THE ACCEPTANCE OF DONATION OF A WATER METER FROM THE POETRY WATER SUPPLY CORPORATION AND DESIGNATING USE; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town of Poetry, Texas is a Type A General-Law Municipality ("Town") organized and operating under the laws of the State of Texas; and

WHEREAS, section 51.015(a) of the Local Government Code provides a Type A General-Law Municipality may take, hold, purchase, lease, grant, or convey property located in or outside the municipality to carry out a municipal purpose; and

WHEREAS, section 51.015(b) of the Local Government Code authorizes the governing body of a Type A General-Law Municipality may manage and control the property belonging to the municipality; and

WHEREAS, the Poetry Water Supply Corporation has offered to donate a water meter for the Town's use subject to the condition that ownership of the meter will revert back to the Poetry Water Supply Corporation, if the water meter ceases to be used for town business; and

WHEREAS, the Town Council of the Town of Poetry desires to accept the donation of the water meter from the Poetry Water Supply Corporation, acknowledge the condition on the donation, and designate the use of such property;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF POETRY, TEXAS:

SECTION 1. AUTHORIZATION OF ACCEPTANCE OF DONATION OF PROPERTY FROM POETRY WATER SUPPLY CORPORATION. The Town Council authorizes the acceptance of donation of property from the Poetry Water Supply Corporation more particularly described as a water meter ("Property") to carry out a municipal purpose. The Town Council accepts the donation subject to the condition that ownership of the water meter will revert to the water supply corporation should the Town ever cease to use the property for town business. The Mayor, or designee, is hereby authorized to execute any documents necessary to transfer and accept title to such property in the name of the Town.


SECTION 2. DESIGNATED USE. The Town Council hereby authorizes the Property to be used for any municipal purposes including to provide a water supply for the Town's use in any of the Town's property and buildings;

SECTION 3. SEVERABILITY. If any section, paragraph, sentence, clause, phrase or word of this Resolution or the application thereof to any person or circumstance is held invalid or unconstitutional, such holding shall not affect the validity of the remaining portions of this Resolution, and the Town Council hereby declares that it would have passed such remaining portions despite invalidity or unconstitutionality.


SECTION 4. EFFECTIVE DATE. This Resolution shall be effective immediately upon its passage.
